# LL.M.-Program "International Legal Studies"

9 October 2008 was graduation day for the first LL.M. class of students of the University of Vienna's new International Legal Studies Program. After two years of preparation, the program which had begun for the very first time in the winter term 2007 was able to celebrate its first graduates one year later in a final ceremony on the top floor of the Juridicum.

The full-time program stretches over two semesters. The eleven participants of the first year program included four professionals in jobs and seven university graduates.

All participants met the high demands of the English speaking LL.M.-Program which focuses on subject areas such as International Organizations, International Economic Law as well as Dispute Settlement. They accomplished 4 seminars and 8 mandatory courses with final exams, and also wrote a master thesis over the summer months which had to be handed by the end of August 2008.

The content of teaching, class schedules and examination modalities had been determined one year earlier by Prof. Reinisch together with the LL.M.-Program's professorial board consisting of Prof. Gerhard Hafner, Prof. Hanspeter Neuhold, Prof. Manfred Nowak, Prof. Christoph Schreuer, Prof. Friedl Weiss and em. Prof. Karl Zemanek.

Mag. Claudia Luxon, MA was and is in charge of the entire administration of the LL.M.-Program. She acts as the first contact person, as course-administrator of the particular lecturers together with their manuals and readers, as coordinator of study trips and external lecturers, and also is responsible for all the advertising measures and the entire financial procedures.

In addition to the study program, the LL.M. participants were also offered a lecture series with distinguished extra-curricular lecturers such as: the chairman of the World Bank Inspection Panel, Dr. Kiene, the Head of Section for International Trade Law Division at UNCITRAL, Dr. Estrella-Faria, the Associate Expert of the UN Office on Drugs and Crime Prevention (UNODC), Dr. Gottwald, the American Embassy's chargé d'affaires in Vienna, Mr. Scott F. Kilner, as well as the Head of the Office for Outer Space Affairs (UNOOSA), Dr. Hedman.

# LL.M.-Program "International Legal Studies"

Within the scope of offers the LL.M.-Program also organised two non-compulsory study trips to Geneva and to The Hague. In Geneva, thanks to the contacts of Prof. Weiss and Prof. Nowak, the participants were able to witness hearings at the WTO and the presentation of reports of the UN System for the Protection of Human Rights. At the Hague, Prof. Hafner and Prof. Nowak offered a comprehensive visiting program to the International Court of Justice, the International Criminal Court and at the tribunal for the former Yugoslavia.

Internships at the International Organizations in Vienna and other seats were made available for a number of students of this LL.M.-Program. This affirms the demands for hands-on training and contributes to the LL.M.-Program's attractiveness.

#### **CONSENT Project**

The Department is the Austrian partner of the scientific project CONSENT sponsored by the EU Commission which addresses the multiple dimensions of European integration within the framework of the EU and in which both universities as well as other research institutes from all member states of the Union participate.

Prof. Neuhold is member of the international advisory board for the project of a new edition of the Encyclopedia of Public International Law which is headed by the Director of the Max Planck Institute for Comparative Public Law and International Law in Heidelberg, Prof. Rüdiger Wolfrum.

#### Manfred Nowak

#### REFGOV – Reflexive Governance in the Public Interest

The focus of the research project Reflexive Governance is to investigate institutional mechanisms which shall compensate market deficits by other means than command and control structures in the name of public interest. The objective is to identify and evaluate these new mechanisms. In addition, there will be proposals of how to improve institutional governance. The network consists of five sub-networks. Prof. Nowak is the Austrian project coordinator of the sub-network "Fundamental Rights Governance".

The question this sub-network seeks to address is whether, in the present situation of the fundamental rights policy, fundamental rights may contribute effectively to the definition of the public interest in the Union, and if not, which mechanisms ought to be devised to make that contribution effective, and thus to ensure the mutual reinforcement of fundamental rights and the provision of services of general economic interest towards increased social and territorial cohesion.

IDP Legislators' Manual Project, in cooperation with the Brookings-Bern Project on Internal Displacement (Prof. Walter Kälin)

As its outcome, law and policy-makers on a national level, dealing with the issue of internal displacement, shall be provided with a manual of "hands on" measures, highlighting those issues that domestic law and policy should address to adequately recognise and implement IDPs' rights of the UN Guiding Principles on Internal Displacement. Prof. Nowak is member of the Manual's Steering Group.

#### European Master's Degree in Human Rights and Democratisation (E.MA)

The European Master's Programme in Human Rights and Democratisation (E.MA) is an intensive one-year academic programme to educate professionals in the field of human rights and democratisation. The programme aims to educate and train experts in the field of human rights and democratisation and to prepare them for their future assignments in international organisations (EU, UNO, OSCE and NGOs). During the first semester, students attend at faculty in Venice a comprehensive introduction into the historical, philosophical, anthropological, political and legal foundations of the international human rights regime. The winter semester ends with a field trip to Kosovo. During the summer semester, students are at one of the 41 participating partner universities in the EU, where they attend seminars and work on their thesis. Prof. Nowak represents the University of Vienna in the various bodies of EMA. For 7 years, until December 2007, he was Chairperson of EMA, for which he was awarded the EIUC Medal of Honour in September 2008.

#### **FRALEX**

Replacing the European Union Network of Independent Experts on FundamentalRights, the European Fundamental Rights Agency established in the end of 2007 with FRALEX a group of leading human rights experts which is tasked to develop reports and studies on the human rights situation in each EU member State. Prof. Nowak is member of this group as a Senior Expert/International Expert.

#### Agenda for Human Rights

The Agenda on Human Rights is an initiative of the Swiss Government to mark the 60th anniversary of the Universal Declaration on Human Rights. The Agenda was developed by a Panel of Eminent Persons and its Main Report and Recommendations were drafted by Manfred Nowak, the Panel's Rapporteur. The Agenda sets out contemporary challenges to the enjoyment of human rights and human dignity as perceived by the Panel and makes recommendations to address these challenges. A research programme which engages with multiple institutions around the world is supported by the Agenda, encouraging further research into some of the key contemporary human rights challenges raised.

#### **Third-Party Funded Projects**

# Irmgard Marboe

From 29 June until 19 July 2008, the first "Vienna International Christian-Islamic Summer University" took place in Stift Altenburg (Lower Austria). This project is a "spin-off" of the research project "Vienna International Christian-Islamic Round Table" to which Prof. Marboe has contributed between 2000 and 2008.

The Summer University was funded mainly by the Federal Ministry for Science and Research and the Austrian Development Agency. It was a "§ 27-project", i.e. that the University of Vienna contracted with the funding institutions. The Section for International Law and International Relations in the Department of European, International and Comparative Law of the Faculty of Law was the implementing entity. Prof. Marboe was the director of the project.

The Summer University lasted for 3 weeks and offered 13 courses of approximately 10 hours each. The professors came from Austria, Bosnia-Herzegowina, India, Iran, Camerun, Lebanon, Morocco, Pakistan and Saudi Arabia. The 33 participating students came from Austria, Bosnia-Herzegowina, India, Iran, Israel, Lebanon, Morocco, Pakistan und Saudi Arabia. 18 of them were Muslim, 15 Christian, 17 male and 16 female.

The programme included courses on Introduction to Christianity and Islam, Human Rights from a Muslim and Christian Perspective, Migration in an Interconnected World,

Women in Islam and Christianity, Political Violence, Poverty and Social Rights, International Law and Constitutionalism, Religion and the State as well as International Order and Religion.

Excursions to Vienna and Melk as well as receptions at Stift Altenburg and at the Mayor of Vienna completed the programme. At a ceremony at the Austrian Academy of Sciences on 25 October 2008 which celebrated the past years' dialogue initiatives and publications and at which the Federal President Heinz Fischer, the Federal Minister for Science and Research Johannes Hahn, the Archbishop of Vienna Cardinal Schönborn and the former president of Iran, Seyyed Mohammad Khatami, participated, the Summer University was also presented. At this occasion the Federal Minister announced that the Summer University will continue to be supported and should be organised again in 2010.

<u>Commentary on the UN Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (CAT-Commentary)</u>

Quality Assurance for First Instance Asylum Proceedings in Austria

Over a period of thirteen months, starting January 2007, a respective analysis based on a sample of 100 proceedings will be conducted and scientifically edited. The project will be implemented in cooperation with members of the Federal Asylum Office. Moreover, the project team is supported by a steering committee consisting of representatives of the UNHCR, the Red Cross (ACCORD), the Independent Federal Asylum Tribunal, the Ministry of the Interior, the Federal Asylum Office and the Ludwig Boltzmann Institute of Human Rights.

The project is financed by the European Refugee Fund and co-financed by the Austrian Ministry of the Interior.

<u>Domestic Violence from a Human Rights Perspective. Prevention and Protection of Violence against Women and Children – the Austrian Experience</u>

This study analyses domestic violence in Austria in its legal and factual dimension from a human rights perspective. Particular attention is paid to specific women's rights and child rights standards and the implications both for prevention as well as effective protection of victims of violence.

The study particular pursues the following questions: How has the international and European human rights/women's rights/child rights framework developed recently with respect to violence in the family (see also, e.g. the recent 2006 UN Studies on Violence against Children, and against Women, respectively)? What are the binding legal obligations for Austria? How is Austria complying with its international obligations? What are the areas in most pressing need of reform in Austria beyond the existing a specific Law on Protection against Violence, which particularly considers the specific needs of children and specific social groups such as migrants? What is the added value of a rights-based approach to prevention and protection from violence?

The "Violence in the Family" project is funded by the Anniversary Fund of the Austrian National Bank.

# August Reinisch, Christina Knahr

#### International Investment Law in the Practice of International Arbitration

Over the past fifteen years investment arbitration under the auspices of the International Centre for Settlement of Investment Disputes (ICSID) as well as ad hoc arbitration and arbitration under the UNCITRAL Rules has increased considerably. The practice of investment tribunals has significantly shaped the substantive investment law.

This project systematically analyzes the existing case law according to the following main topics: admission requirements, standards of protection (fair and equitable treatment, full protection and security, national treatment, most-favored-nation treatment, arbitrary and discriminatory measures), expropriation and the standards of compensation for expropriation. The research focuses on the actual application of the investment standards found in Bilateral Investment Treaties (BITs) and other international investment agreements by investment tribunals. A thorough analysis of arbitral decisions and

awards is being conducted in order to determine the actual content of international investment law.

The results of the research undertaken during the project are intended to be assembled in a book. Due to its planned structure as a commentary, it will provide easily accessible informa-tion and reference to the scholarly community and practicing lawyers, counsels and arbitrators alike. At the same time, it will explain the broader international law background of many decisions, analyze the doctrinal background of their reasoning and discuss the implications of the way how investment standards have been interpreted.

#### International Law in Domestic Courts

International law is increasingly gaining importance in a globalised world. Consequently, domestic courts have to deal with a rising number of cases relating to, inter alia, the relationship between international law and domestic law in general, the determination of the legal status of foreign States in the domestic context or the analysis of acts of foreign States violating in ternational law. The use of international law before domestic courts is an important factor in determining the effectiveness of norms of international law. Thus, more and more practitioners as well as academics also refer to domestic court judgments.

The project "International Law in Domestic Courts" (ILDC) acknowledges this development. It comprises carefully annotated domestic cases relating to international law. The (English) presentation in the database notably contains key words, facts, the court's holding as well as short case commentaries, in order to effectively improve individual research requests.

On the international level, the project forms part of a comprehensive research cooperation, including academics from Washington, D.C., Amsterdam, Pretoria, Tel Aviv and Vienna as well as other renowned universities in order to assure top academic quality and the inclusion of the highest number of jurisdictions possible. This approach equally facilitates the comparative analysis of the reception of international law in domestic courts.

In addition to the ongoing case reporting from Austria as well as the review of foreign cases, the project was essentially advanced during the last year. Notably the research cooperation among the national reporters was strengthened both from an administrative as well as a substantive standpoint by means of international conferences, such as the "Vienna Training Session" from 22 – 24 November 2007. The ILDC database was officially launched on 27/28 March 2008 in the course of the "ILDC Colloquium" held in The Hague, which was attended by over 150 participants. The close cooperation with foreign students of the LL.M course in International Legal Studies concerning the reporting of cases from their home jurisdiction allows to include case reports from underrepresented legal systems in the ILDC database.

# **Section Library**

New orders and subscriptions of the Section for International Law and International Relations as regards books, periodicals and collections were transferred to the faculty library. Financial shortages led to delayed processing of new orders and cancellations of periodicals with multiple subscriptions in the University Library at large. Cost intensive inter-library loans increased in turn.

Furthermore, the material for courses and seminars was assembled and put on the Reserve-Shelf (Section's corner of the 5th floor) for the students. The students of the LLM-Programms ,International Legal Studies' received workspace and materials. An introduction to legal online research the university computer system was given.

In cooperation with the members of the Section proof-reading and revisions of publications were conducted, especially for the Austrian Review of International and European Law (ARIEL).

From now on Mag. Helmut Prantner alone remains in charge of library matters concerning the section and will mantain contact to the faculty library.

# **International Student Competitions**

# Telders International Law Moot Court 8-16 April 2008

The Department of International Law and International Relations took part in the 31st Telders International Law Moot Court Competition with a team consisting of Elisabeth Lischka, Julia Kriz, Courtney Furner and Luciano Duque. Each year more than 40 teams from all over Europe participate in the final rounds of this renowned student competition which take place at the Peace Palace of the International Court of Justice. The Austrian Telders team which was coached by Magistra Kathrin Gabriel demonstrated an excellent performance. Here, Courtney Furner received the Award for the Best Oralist as she had distinguished herself out of all the participating speakers. Moreover, the Austrian Telders team wrote the Best Respondent Memorial of the 2008 Telders Competition. In the overall ranking it finished fifth among all European teams.

Again this successful participation in the Telders International Law Moot Court Competition, was the product of extra-ordinarily hard work; preparations for the final rounds had been going on since October 2007 so that the competitors finally devoted almost all their time to this project.

Every year, a hypothetical case forms the basis for a discussion of timely and controversial questions of international law on a high level. This year's case revolved around a legal dispute between two states and involved public international law, including the law of treaties and questions regarding state responsibility and liability, public international air law, the application of European aviation rules and the binding force of international safety rules.

# Concours Jean Pictet – International Humanitarian Law Schwarzenburg 19-25 April 2008

A team of the University of Vienna's Faculty of Law participated in the quarter-finals of the 20th edition of the Jean-Pictet Competition on International Humanitarian Law (IHL), taking place in Schwarzenburg/Switzerland in April 2008. The event is sponsored mainly by the International Committee of the Red Cross, by several national Red Cross Societies as well as by the Swiss Federal Department of Foreign Affairs and focuses on putting into practice the theoretical knowledge in the field of IHL acquired in

the preparation for the Concours . Altogether, 65 universities from all over the world competed in real-life-simulations in one of the working languages (French, English or Spanish) against each other. The team of the University of Vienna, Mag. Matthias Jurek, Mag. Wolfgang Strasser and Natalie Harsdorf Enderndorf qualified via written submissions for the quarter finals in Schwarzenburg/Switzerland. Main topics of this year's competition were the current challenges to IHL such as the status of private military companies, cluster munitions, non-state actors, and an upgraded International Fact-Finding Commission. The team was coached by Asst Mag.a Lisa Stadlmayr, Asst Mag.a Catherine Quidenus and Asst Mag.a Mag.a (FH) Lena Pampalk, who had participated as Austria's very first team in the competition in 2007.

# National Model United Nations 22-26 April 2008

The Department of International Law and International Relations in 2008 took part in the National Model United Nations, New York, with a 14-person team. The co-operation with the Vienna University of Economics and University of Vienna Institutes of Political Science, and Philosophy was across disciplines and fully funded by public and private sources. The team won the award for best position paper and the award for most committed delegate. The 3000 American and international participants were assigned diplomatic positions in the Unite Nations System with the task to push their national agenda in the various committees. The team coached by Assistant Mag. Helmut Prantner overall demonstrated an excellent performance representing Bolivia in a simulation of international conflict management.

# Diploma Theses, Diploma Exams

During the academic year, 360 Diploma Exams and 16 Diploma Theses in International Law as well as numerous Exams and Theses in European Law were administered by members of the Section for International Law and International Relations of the Department for European, International and Comparative Law. 16 students received the certificate of the Elective Field of Specialization "Law of International Relations", organized by the Section for International Law and International Relations.

# Coordination of Exchange-Programs

Three members of the section (Prof. Gerhard Hafner, Prof. Irmgard Marboe und Prof. Erich Schweighofer) act as Erasmus-coordinators. They are responsible for more than 100 exchange places of the European student exchange programme, thus for most of the places of the Faculty. Therefore, the Section for International Law coordinates the annual Erasmus selection procedure for the entire Vienna Faculty of Law.

The Section has created a homepage for the Erasmus-programme (http://public.univie.ac.at/index.php?id=13401/) which is updated regularly.

The support service of the Erasmus-programme includes information as student exchange possibilities both at public events and in personal consultations, the elaboration and signature of the "learning agreement" including subsequent changes and adaptations, as well as guidance and supervision of the procedure of recognition upon return. This includes also writing certificates of recognition for diploma seminars and supplemental examinations for diploma or module exams, if necessary.

The Erasmus-coordinators act also as contact persons for incoming students from abroad, in particular as regards advice and support with the "learning agreement".

In December 2006, an information event took place in the building of the Faculty of Law which was attended by more than 100 students. There is relatively great interest in studying abroad, but in comparison to the overall number of students at the Vienna Faculty of Law, this than still is space for further development. Many students are concerned about a prolongation of their studies. Also the financial burden is considerable as Erasmus-grants do not cover the addi-tional costs of studying abroad.

In February/March 2007, the section organised the Erasmus selection procedure of the Faculty of Law for the academic year 2007/08. More than 148 candidates applied. After the receipt of written applications, oral hearings took place in the beginning of March. The individual programs in the academic year 2006/07 are presented further detail below:

# Prof. Hafner and Mag.<sup>a</sup> Stadlmayr

In the framework of the ERASMUS-Programme coordinated by Prof. Hafner and administered by Mag.a Stadlmayr, student-exchanges are organized with the following 18 universities:

Nanterre, Paris X; Université Paris Nord XIII; Institut d'Etudes Politiques de Paris (Sciences Po); Université de Bourgogne, Dijon; Université Catholique de Louvain, Louvain-La-Neuve; Université Catholique de Lyon; Università degli studi di Bologna; Università degli studi di Urbino; Universiteit van Amsterdam (Amsterdam International Law Program); Rijksuniversiteit Leiden (Leiden Law Courses); Katolieke Universiteit Nijmegen; University of Wolverhampton; Universidad Autónoma de Madrid; Universidad de Alcalá, Alcalá de Henares - Madrid; Georg-August-Universität Göttingen; Universität Ljubljana.

After the selection process in March 2007 and the attribution of remaining places in autumn 2007, 46 students spent one or two semesters at one of the universities mentioned above.

In exchange, 25 incoming-students of those universities were accepted and looked after at our faculty.

#### Prof. Marboe

The framework of the Erasmus-programme of Prof. Marboe consists of contracts with 31 universities. As the 32<sup>nd</sup> university, the University of Kent (Canterbury, UK) was welcomed this year. From 2008/09 onward there will be 3 places for a full academic year. The number of places for the University College Dublin (Ireland) was increased from 1 to 5 from the year 2008/09. In the academic year 2007/08, 59 students were nominated to study abroad for one semester or for one year. In the same period, 34 students from partner universities abroad came to study at the Vienna Faculty of Law.

In addition to exams and exercises in European Law and Public International Law, students abroad largely attended elective subjects and diploma seminars. Erasmus studies abroad often induce students to develop a particular interest in the international dimension of law and jurisprudence. After their return many Erasmus-Outgoings successfully participate in inter-national law Moot Courts or complete elective fields of specialisation related to international issues (European Law, Law of International Relations, Human Rights, Private International and Comparative Law, etc.).

#### Prof. Nowak

In his capacity as National Director, Professor Nowak represents the University of Vienna at the "European Master's Programme in Human Rights and Democratisation" (EMA). Every year, 90 students from EU Member States and other countries take part in the two semester programme. The first semester is taught in Venice, Italy; during the second semester, the students stay at one of the 41 partner universities in order to write their master thesis. In the summer term 2008, Professor Nowak supervised four EMA students from Croatia, Iran, Netherlands, and Slovenia.

# Prof. Schweighofer and Mag. Geist

The Centre for Computers and Law (Professor Schweighofer, Anton Geist) organises the ERASMUS student exchange program "Computers and Law". The program, which brings together 12 universities, is primarily aimed at students who want to acquire additional knowledge in the field of information technology (both technical knowledge and legal expertise) by going abroad using the Erasmus framework.

In the winter term 2007 and the summer term 2008, 9 Viennese students travelled abroad while 7 foreign students came to Vienna.

Since 2006, the exchange-program with the William & Mary School of Law offers students of the Law School of Vienna to attend law courses at the partner institution in Virginia, United States on the basis of a mutual tuition fee waiver (www.wm.edu/law).
