Dear readers,

As in previous years, the many activities of the members of the Section for International Law in teaching, research, legal practice and public debates throughout the academic year 2019/2020 furnish an impressive spectrum of material for this year's Annual Report.

During winter term 2019/2020 these activities included, apart from regular teaching and examinations, lectures at international conferences, numerous publications, contributions to international committees and working groups, and the hosting of five Round Table lectures and three conferences (the 4th Vienna Investment Arbitration Debate, the Academic Forum on ISDS and the Conference "50 Years Vienna Convention on the Law of Treaties" on the occasion of Prof. Karl Zemanek's 90th birthday) at our Section.

In spring 2020, however, everyday life all around the world took an unexpected turn. The COVID-19 pandemic not only impacted private lives, but also required rapid and efficient adaptations of professional activities to face the new circumstances. This was also true for our teaching and general staff at the Section for International Law, who were confronted with a considerable increase in workload and had to demonstrate a high degree of flexibility.

As Head of the Section, I would like to use this opportunity to once again express special gratitude and recognition to all members of the Section for International Law for their efforts in these trying times, and to commend their impressive performance in keeping our Section operational.

Despite the COVID-19 pandemic, the closure of our university and a general lockdown, teaching and examinations at our Section continued. Our teaching staff conducted a total of 20 elective courses, four practical courses, two lectures, two cross-faculty courses and two review courses in digital formats. Additionally, the First Cross-Subject Examination (FÜM I) and numerous oral exams were undertaken either digitally or in person by strictly adhering to health and safety measures. Preparation for moot courts too, continued to take place – as well as a total of four (Virtual) Round Table Lectures and the publication of numerous articles and books.

All this was made possible by the tireless efforts of the entire staff of the Section. Their dedication also enabled our Section to maintain its excellent quality of teaching and research in international law throughout a global pandemic.

It is therefore my great pleasure to present our readers the Annual Report of the Section for International Law for the eventful period between October 2019 to September 2020 and I hope it provides an interesting read.

Elective Field of Specialization “Law of International Relations”

Coordination: Prof. Dr. Ursula Kriebaum

This module is directed at students with a special interest in acquiring an international and interdisciplinary perspective. Due to globalization and the increasing inability of individual states and regional organizations (e.g. the EU) to solve various political problems, a comprehensive approach, including global legal solutions, is indispensable. The “elective field” is designed to, on the one hand, deepen knowledge in the areas of international law already covered by the regular curriculum and, on the other hand, to offer information on additional topics. Consequently, the “elective field” focuses on international economic law, the international protection of human rights, international criminal law, international organizations and multilateral diplomacy, the legal and political aspects of international security, and the international status of Austria since 1918. Since English has become the global “lingua franca” in international law, many courses in the elective field are offered in English, alongside other languages, in addition to German. LL.M.-Program “International Legal Studies”

Prof. MMag. Dr. Christina Binder, E.MA

Christina Binder holds the Chair for International Law and Human Rights Law at the Bundeswehr University Munich. Until 2017, she was University Professor of International Law at the Department of European, International and Comparative Law at the University of Vienna, as well as Deputy Director of the interdisciplinary Research Centre “Human Rights”. She is member of the Executive Boards of the European Society of International Law and of the European Inter University Center for Human Rights and Democratisation (EIUC). In addition, Christina Binder is election expert for the Congress of Local and Regional Authorities of the Council of Europe and has served as legal and electoral expert for EU and OSCE/ODIHR election observation and assessment missions in several countries (ao. to Albania, Aserbaidjan, Georgia, Kazakhstan, Venezuela, Nepal).



Prof. Dr. Gerhard Hafner, ret.

Gerhard Hafner is the former Director of the Department of European, International and Comparative Law at Vienna University's Law School and former Deputy Chairman of the German Society of International Law. In addition to being a Legal Consultant to the Austrian Ministry for Europe, Integration and Foreign Affairs and Member of the Governing Board of the European Studies Institute in Moscow, he is a member of the Institut de Droit International and of the Permanent Court of Arbitration.



Prof. Dr. Hanspeter Neuhold, ret.

Hanspeter Neuhold is Professor emeritus of International Law and International Relations at the University's Law School; Academic Director of the postgraduate Master of Advanced International Studies (M.A.I.S.) programme jointly organised by the University of Vienna and the Diplomatic Academy Vienna; and former Director of the Austrian Institute for International Affairs.



Mag. Claudia Luxon, MA

Claudia Luxon has been Program Manager of the LL.M. Program in International Legal Studies at the Section for International Law and International Relations since 2006. After graduating in Classical Archaeology, Fine Arts, and later in Arts Management, she has enlarged on vocational training programs and earned a Diploma in European Project Management in 2000. Since then she has devoted most of her work to establishing and promoting academic and vocational training programs.

Claudia Luxon manages the LL.M. Program, administers the application procedures and all financial tasks, as well as coordinates all external seminars and lecturers. On the contrary to all the previous years she was, however, unable to organize study trips. 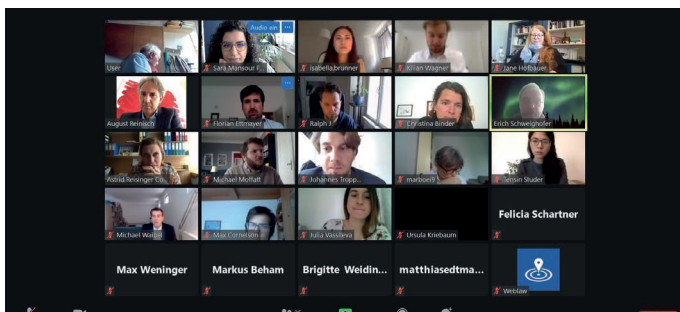

4th Vienna Investment Arbitration Debate

On 11 October, the eve of the meeting of the UNCITRAL Working Group III on ISDS reform, Dr. Moritz Keller (Clifford Chance, Frankfurt) and Prof. Dr. August Reinisch (University of Vienna) hosted the fourth Vienna Investment Arbitration Debate at the Juridicum. As in previous years, the panelists, Prof. Dr. Marc Bungenberg (University of Saarbrücken), Prof. Nassib Ziadé (Bahrain Chamber for Dispute Resolution), Prof. Irmgard Marboe (University of Vienna) and Liz Snodgrass (Three Crowns, Washington), were assigned a position regardless of their actual opinion. This year's debate focussed on a number of current issues: Is there a need for more coherence in investment arbitration and thus a need for ISDS reform? How will ISDS reform affect the substantive standards of treatment, in particular the standard of fair and equitable treatment? What are the implications of the recent decisions of the Court of Justice of the European Union, Opinion 1/17 and the Achmea judgment, for the future of investor-state arbitration within and outside the EU? The Vienna Investment Arbitration Debate ended with a keynote speech by Prof. Dr. Hans van Houtte, former President of the Iran-United States Claims Tribunal.



Academic Forum on ISDS

On October 16, 2019, the fourth Academic Forum Sessional Event on the occasion of the UNCITRAL Working Group III (Investor-State Dispute Settlement, ISDS) took place in the Juridicum, organized by Prof. Dr. Ursula Kriebaum and the CIDS-Geneva Center for International Dispute Settlement. The meeting of academics most of them also taking part in the Working Group Meeting took place to discuss this year's papers. They focused on the topics under discussion in the Working Group. The papers dealt with reflective losses, third party funding, selection, appointment and code of conduct for arbitrators/judges and the proposal for an advisory center aiding developing countries as well as small and middle-sized investors. After the presentation and discussion of the papers, the participants exchanged their views about future steps and the up-coming conference in Vienna 2020.

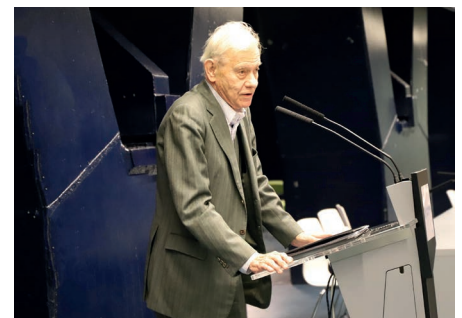


50 Years Vienna Convention on the Law of Treaties

The Conference “50 Years Vienna Convention on the Law of Treaties (VCLT)”, organised by August Reinisch and Christina Binder on the occasion of Prof. Zemanek’s 90th birthday on 18 November 2019, assembled more than 120 participants from all over the world; academics as well as practitioners.

The Conference took the VCLT’s anniversary as a starting point to examine the law of treaties over the past five decades. Panels, consisting of Hanspeter Neuhold, Veronika Bílková, Georg Nolte, Catherine Brölmann, Gerhard Hafner, Christina Binder, Hélène Ruiz Fabri, and Dire Tladi, examined the historical origins of the VCLT; developments in the law of treaties over the last 50 years, including the interpretation of treaties, subsequent practice in relation to treaties, reservations, the provisional application of treaties and treaty termination. A final panel dealt with the “eternal question of ius cogens.”

Indeed, the Vienna Convention on the Law of Treaties (VCLT), negotiated and adopted in Vienna in 1969, is frequently called the “treaty of treaties”. The VCLT is the most important instrument of modern treaty law, with the vast majority of its provisions codifying customary international law. State and judicial practice are continuously guided by the authoritative rules incorporated in the VCLT. At the same time, the VCLT’s general rules were further developed and modified by subsequent practice as well as by developments especially in specific treaty regimes. All this was discussed at the conference’s stock-taking in the year of the 50th birthday of the VCLT.



VICISU – Vienna International Christian-Islamic Summer University (Stift Altenburg); univie:summerschool intercultural studies

The “Vienna International Christian-Islamic Summer University - VICISU” takes place every two years under the direction of Prof. Irmgard Marboe since 2008, most recently in August 2018. The Summer University is managed as a third-party funded project of the Faculty of Law and advertised under the label “univie: summerschools” of the University of Vienna. During the reporting period, preparations for the Summer University started, which was supposed to be held at the Abbey of Altenburg (Lower Austria) in August 2020. However, due to the measures to contain Covid-19 these preparations were suspended in March 2020.

Visiting Professors and Researchers

Professor Dr. Georg Borges

Full Professor of Civil Law, Legal Informatics, German and International Commercial Law and Legal Theory at Saarland University.

After high school graduation and military service, Prof. Dr. Georg Borges studied law at the universities of Frankfurt/Main, Geneva and Bonn, as well as economics at the FernUniversität Hagen. In addition, he worked as an assistant tax consultant from 1984 to 1986 (graduation in 1987). After his second legal state examination (1994), Prof. Dr. Borges worked for the internationally oriented law firm Gleiss Lutz from November 1994 to January 1997. Afterwards he was assistant to Prof. Dr. Norbert Horn at the Institute for Banking Law at the University of Cologne.

He received his doctorate in 1996 on the subject of "The Double Exequatur of Arbitral Awards. The recognition of foreign arbitral awards and exequatur decisions" at the University of Konstanz. His habilitation was granted in 2002 with a thesis on "Contracts in electronic commerce. Conclusion of contract, proof, form, localization, applicable law" at the University of Cologne.

This was followed by professorships at the universities of Augsburg, Bochum and Kassel. In the winter semester of 2003 he was offered a position at the University of Kassel. In the summer semester of 2004, he was offered a position at the Ruhr-University of Bochum, where Prof. Dr. Borges held the chair for Civil Law, German and International Business Law, in particular IT Law, until the summer semester 2014. He was then appointed to the University of the Saarland, where he currently holds the Chair of Civil Law, Legal Informatics, German and International Business Law and Legal Theory.

From April 2012 to August 2015, Prof. Dr. Borges was a judge at the Higher Regional Court of Hamm. As a university professor, he served as judge at the Higher Regional Court of Hamm as a so-called second full-time position (with a significantly reduced scope of work). Prof. Dr. Borges was assigned to the 27th Civil Senate of the OLG Hamm, which has its focus on corporate law and insolvency law.



Professor Dr. Catherine Kessedjian, LL.M.

Catherine Kessedjian is the Deputy Director of the European College of Paris. She teaches European Business Law and International Dispute Resolution at the University Panthéon-Assas Paris II, where she is the Director of a Master program in European Law. She teaches seminars on Private International Law, International and Comparative Dispute Resolution and Arbitration.

In 2004, she was appointed a Hauser Global Professor at New York University School of Law where she teaches International Commercial Transactions and a seminar on Rule Making Processes in a Global World. In 2010, she taught a class in International Dispute Resolution at Yale Law School.

She currently acts as mediator or arbitrator in a selected number of transnational disputes either ad hoc or under the auspices of, among others, ICSID, ICC, LCIA and AAA.

Before joining Paris II, she was Deputy Secretary General of the Hague Conference on Private International Law (1996-2000), on secondment from the Université de Bourgogne in France. At The Hague Conference, she was in charge of the preparation and monitoring of the negotiations for a proposed world-wide Convention on jurisdiction and judgements. She was also in charge of commercial matters, including electronic commerce.

She was a practising attorney in Paris from 1982 to the end of 1998, focusing on transnational litigation and international business transactions.

She received her legal education from the University of Paris (Doctorate) and the University of Pennsylvania Law School (LLM).

She is Chevalier de la Légion d'Honneur (France), Chevalier de l'ordre national du Mérite (France) et Chevalier dans l'ordre des Palmes académiques (France).



Projects

National Point of Contact for Space Law Austria

The “National Point of Contact for Space Law Austria” (NPOC Space Law Austria) is located at the Section for International Law and International Relations since 2008 and is headed by Professor Irmgard Marboe. It is the Austrian contact point for space law of the European Centre for Space Law (ECSL) at the European Space Agency (ESA). Its activities are supported by the Austrian Federal Ministry for Climate Action, Environment, Energy, Mobility, Innovation and Technology (BMK) and the Austrian Research Promotion Agency (Österreichische Forschungsförderungsgesellschaft - FFG) in the framework of a third-party funded project.

The project aims at promoting space law through research and teaching as well as through advisory activities and public events. In the area of teaching, courses on space law are offered in the framework of the two Elective Fields of Specialization “Law of International Relations” and “Technology Law”. The aim of these courses is to give students an introduction to space law related issues as well as an overview of recent developments in the field of space law. In addition, study trips, for instance to the United Nations Office for Outer Space Affairs (UNOOSA) in Vienna, provide students with insights into practice.

In order to raise public awareness, the NPOC Space Law maintains a dedicated website (<http://www.spacelaw.at>) and regularly organizes public events. The NPOC Space Law was involved in the organization of a Round Table on “Legal Issues in Planetary Defense” which took place on 19 October 2019 just before the International Astronautical Congress in Washington D.C., USA, at the premises of the American Society of International Law (ASIL). The event was organized together with ASIL and the International Institute of Space Law (IISL). During the event the work of the Space Mission Planning Advisory Group (SMPAG) Ad-hoc Working Group on Legal Issues, in which members of the NPOC Space Law Austria participate, was discussed with international experts, including the Legal Advisor of the United Nations, Stephen Mathias. From 18 to 22 November 2019, the United Nations/Austria World Space Forum “Access to Space4All” took place at the premises of the United Nations in Vienna, in which the NPOC Space Law took part in the organization and through panel participation and rapporteur functions. From 1 to 3 September 2020, the United Nations/Austria Symposium “Space Applications for Sustainable Development Goal 13: Climate Action” was organized as a virtual conference in which the NPOC Space Law Austria was involved as a co-organizer and through co-moderations. In presentations and discussions, the importance of space technologies, applications and activities in supporting climate action and in contributing to global efforts to mitigate and adapt to climate change was discussed. Due to the success of the multidisciplinary approach adopted during the past years, in 2020 the focus of the Symposium was again not only on space technology but also on space law and policy.

In addition, members of the NPOC also developed several publications in the area of space law (see list of publications). Currently, the NPOC is preparing the publication of a book entitled “Legal Aspects of Planetary Defence”. In over 20 chapters by renowned international experts and academics the topic planetary defence is discussed in detail. The book will be published in 2021 by Brill/Nijhoff.



Members of the NPOC also participated in numerous international and national conferences and events in the space field, including a panel on “Commercial Space Legislation – US and Global Developments” at the 12th Nebraska Space Law Conference “Global Perspectives on Space Law and Policy” in Washington D.C., USA on 18 October 2019. Furthermore, members of the NPOC gave presentations at the 70th International Astronautical Congress which took place from 21 to 25 October 2019 in Washington D.C., USA on the occasion of the 50th anniversary of the Apollo 11 Moon landing (see list of presentations).

Moreover, the NPOC Space Law was represented in the Scientific and Technical Subcommittee of the UN Committee on the Peaceful Uses of Outer Space (UNCOPUOS) as well as in several Working Groups, in particular the Working Group on the Space2030 Agenda, as part of the Austrian delegation and worked closely together with the BMK in the preparation and representation of Austria. The NPOC was particularly involved in the work of the Ad-hoc Working Group on Legal Issues of the Space Mission Planning Advisory Group (SMPAG). Since 2016 the Working Group has elaborated a report on legal aspects of planetary defence, which was adopted by SMPAG in February 2020. In this connection, members of the NPOC participated in several meetings of SMPAG and the Legal Working Group. Other UN related meetings, such as in particular those of the UN Committee on the Peaceful Uses of Outer Space and its Legal Subcommittee, in which NPOC representatives regularly participated in the Austrian delegation, were cancelled due to the measures to contain Covid-19. Several topics in the area of space law which wait for further development in these bodies, in particular the legal questions of space resource utilization and sustainability of space activities, were postponed to 2021.

In the academic year 2019/2020, a team from the University of Vienna participated in the Manfred Lachs Space Law Moot Court for the seventh time. The NPOC Space Law Austria, headed by Prof. Marboe, was to host the European Rounds in 2020. However, due to the Covid-19 pandemic this was impossible and the oral rounds had to be held online. The three students, Katharina Harreiter, Rosanna Hoffmann and Hristina Talkova, were coached by the former Moot Court participants, Clara Baumgartner and Michael Friedl. The Austrian team was able to reach the finals, as was the case also last year, and for the first time it won the European Rounds of the competition. Hristina Talkova was awarded the distinction of “Best Oralist” (see detailed report under “Moot Courts”). For 2021 the ECSL Board of Directors has already decided that the European Rounds should again be hosted by NPOC Space Law Austria together with ECSL, hopefully as a real event at the Juridicum in Vienna.

Rule of Law and International Investment Law

This research project builds on the research conducted within the framework of two previous FWF projects (“International Investment Law in the Practice of Arbitration” and “International Investment Law in the Practice of International Arbitration II”) and will now focus on a critical evaluation of the role of the rule of law in modern investment arbitration. The current – mainly descriptive – assessment of the content of investment law will be taken as point of departure from which the project will turn towards a primarily critical inquiry into investment arbitration’s ability to cope with rule of law demands.

This research project has been developed by the project leader in consultation with leading investment arbitration experts and practitioners in the context of the International Law Association’s work on investment law and other scholarly co-operations in the form of joint conference organizations or co-editorships of books and journals in the field. A number of prominent investment law experts have expressed their willingness to continue co-operating with the project leader Prof. August Reinisch and his assistant, Jose Mag-naye (until August 2018) and Johannes Tropper (November 2018 until September 2019), respectively; it should therefore lead to transparent research outcomes in the form of conferences and publications.

The rule of law in international law, in general, and in international investment arbitration, in particular, can be studied from different perspectives. The notion of the rule of law itself is not sufficiently clear. In particular, the demands of equal enforcement and independent adjudication of legal rules and principles as well as fairness in the application of the law, legal certainty, the avoidance of arbitrariness and procedural and legal transparency seem to be particularly relevant for investment arbitration. Nevertheless, there is also a growing debate on the rule of law in international law, as evidenced by various attempts to integrate rule of law concerns in the work of the United Nations and other international organizations.

In April 2017 the ILA Committee held its first substantive meeting at the Law Faculty in Vienna. The committee tackled the issue of defining the “rule of law at the international level” based on the understanding of the rule of law in the different domestic legal orders.

The second committee meeting took place in Rome in February 2018, hosted by the Italian Association of Arbitration. The Committee Draft Report prepared by the co-rapporteurs for the 2018 ILA Biennial Conference in Sydney was discussed. The draft report is based on the papers submitted subsequent to the Vienna Meeting dealing with the definition of the rule of law based on a comparative analysis of the domestic notions of the rule of law. The committee continued its work by progressing towards the next phase of tackling the issue of the rule of law in the framework of the substantive standards of investment law.

In December 2019 a workshop was organized by Prof. Reinisch and Prof. Stephan W. Schill at the University of Vienna. The speakers of the workshop explored the relationship between the rule of law and substantive standards of investment law.

The third committee meeting took place in Paris at the Université Paris II – Panthéon-Assas in June 2019. The main topic was the relationship between rule of law and procedural issues of investment law. Following the committee meeting a second workshop was organized by Prof. Reinisch and Prof. Schill which focussed on rule of law problems that exist in the application of substantive standards of investment law.

The papers presented at the workshops in December 2018 and June 2019 will be published in 2021.

KIRAS MALORI – MALware cOmmunication in cRitical Infrastructures

The interconnection of critical infrastructures (e.g., of smart grids) through low-latency communication networks is an essential prerequisite for the integration of renewable energies into today's energy networks. However, this interconnection can serve as substrate for malicious software (malware) to propagate within these infrastructures. Malware such as botnets use communication networks and protocols to abuse existing, known or unknown vulnerabilities in systems, infect new nodes and coordinate their distributed activities. Novel malware conceal their existence or bypass monitoring and detection procedures by means of encryption and hidden communication. The MALORI project investigates methods for detecting secret malware communication in critical infrastructures. Based on selected application cases like, e.g., the electrical vehicle charging infrastructure, MALORI assess the capability of encryption algorithms and protocols to support or hinder hidden communications. The University of Vienna participates in this research project (through its Working Group on Legal Informatics) to identify and elaborate the legal issues related to the monitoring procedures to be developed.

KIRAS COMISO – Crisis Management using Multimodal Interaction for Stakeholders and Citizens

Project COMISO evaluates the use of artificial intelligence to implement novel patterns of interaction in crisis and disaster management and thus addresses unsolved problems in the preparation and availability of heterogeneous data. On the one hand, the interaction of crisis managers with computational systems will be streamlined and made more efficient; both in the command centre and in the field. On the other hand, the interaction with, and engagement of, the public will be individualised and becomes more scalable through new interaction patterns and selective automation. At an early stage of the project, the University of Vienna (Working Group on Legal Informatics) defines the legal framework for the application that is to be developed. In addition, the ethical and gender-specific aspects, which must be taken into account when using e.g. Natural Language Processing (NLP), form part of the project.

KIRAS Hammondorgel – High-performance self-sufficient communication network for authorities and operators of critical infrastructures as a practice-oriented government communication network solution

Within this project, a proof-of-concept for a government communication network for secure operational, tactical and strategic communication will be developed. Already existing state infrastructures, the feasibility of a technical interconnection of wired and wireless IP-based communication networks and the organizational and operational context of the participating organizations shall be taken into account. This also raises legal questions, which are elaborated by the University of Vienna (Legal Informatics Working Group).

KIRAS INTERPRETER – Interoperability in Disaster Management of the next Generation

The KIRAS project INTERPRETER (Interoperability in Disaster Management of the next Generation) is part of the Centre of Computers and Law's research in the legal aspects of Disaster Management. INTERPRETER utilizes the latest software design methods in order to accomplish automated data exchange between the military and civil command and control systems, thereby ensuring the preservation of the semantic integrity of data. Furthermore, based on its modular structure, INTERPRETER enables generic extensibility of its interoperability functionalities, which should ensure that the system can be productively utilized for many years to come. In addition, the project has developed and evaluated an extended concept for IT-supported inclusion of the civil population in the process of crisis and disaster management and in this way addresses the corresponding willingness and preferences of the citizens. The Centre for Computers and Law focuses on the legal framework of the developed architecture including data sharing within disaster management through web-applications or apps.

KIRAS PASA – Public Warning and Alert System for Austria I

The KIRAS project PASA (Public Warning and Alert System for Austria) develops a novel, holistic concept for the warning and alerting of the Austrian population using an interdisciplinary approach. This will improve the effectiveness of civil protection and the efficiency of first responder organizations greatly, which highly depends on the level of cooperation or interference by the civil population and which can e.g. help to optimize the pace of evacuations, actively seek shelter in times of imminent danger or help to offload intensive-

ly used road infrastructure sections. In the current paradigm, the warning and alerting of the civil population in Austria is performed solely in coarse granularity via sirens and via the Austrian broadcasting companies, whereas the current state-of-the-art would enable to reach the population timely and geographically accurately via multiple communication channels (e.g., mobile phones). This would enable the authorities to provide the population with the locally relevant information in real time, opening the potential of optimizing the safety of the civil population as well as its cooperation with the first responder organizations and thus increasing both the organizations' efficiency of operation and the general level of public safety. The envisioned system will precisely reflect the complex legal framework of the Austrian federal system as well as that of Data Protection and E-Privacy. To this end, PASA will continuously evaluate the compatibility of the envisioned solutions with the given legal framework.

KIRAS DARKNET – Darknet Analysis

The KIRAS project DARKNET (Darknet Analysis) aims to develop privacy-aware automated analysis of underground marketplaces and restricted overlay-networks. The main legal issues with these underground forums are the exchange of illegal goods, criminal or terrorist activities or propaganda, which also include criminal activities regarding states security like the acquisition of botnets for attacks on critical infrastructure. The focus of the project therefore lies in the development of privacy-preserving machine learning methods which comply with the right to privacy and exclude uninvolved third parties. The Centre for Computers and Law analyses the legal aspects of this project.

KIRAS CySiVuS – Cyber Security for Transport Infrastructure- and Road Operators

Within the KIRAS project CySiVuS (Cyber Security for Transport Infrastructure- and Road Operators) cyber security aspects of a comprehensive road transport infrastructure system which will be more used intensively by interconnected cars in future, are analysed from the perspective of the road operators. The project partners are developing a reference architecture also taking into account the legal framework. The Centre for Computers and Law analyses the legal issues which have to be considered within risk assessment and will also develop a comprehensive compliance analysis which will cover relevant legal and social aspects of the reference architecture.

KIRAS ACCSA – Austrian Cyber Crises Support Activities

The KIRAS project ACCSA (Austrian Cyber Crises Support Activities) aims to develop comprehensive training, exercise and evaluation concepts for all CKM (cyber crisis management) stakeholders to prepare for cyber crises and thereby reducing response times and error rates in the event of a real cyber crisis. Even in "traditional" crisis and catastrophe management regular exercises (for example, the practice of a chemical accident) have proved to be a feasible means to enable all parties involved to practice. However, a similar use of training and exercise concepts, especially for CKM with technical and organizational support is not yet available. Current exercises often focus on non-dynamic and linear exercises. Technical products for training are currently only commercially offered, available only to members of certain specialist circles and not open to the public. The CKM concepts, processes, and methods are supported by the implementation of a CKM Toolbox, a system for software-supported training and exercise that spans over several CKM communication levels (e.g., engineering, management, first responder, policy makers). Building on the results of past projects, the Centre for Computers and Law supports the development of this CKM Toolbox by analysing legal bases for possible measures of the various actors within cyber crisis management, including developments in jurisprudence and legislation on a European and national level.

KIRAS – Smart Identification

The KIRAS project Smart Identification aims at supporting the fight against organized human trafficking on a national and European scale. To support crime fighting in this area, information on exodus routes or routes of human trafficking as well as on the identity of victims is required. The public authorities face the problem of non-identifiability if only uncertain and doubtful information is available. The project focuses on the analysis of exodus routes, the detection of unaccompanied minors and the identification of victims using if possible their documents and their smartphones. While smartphones collect and contain a lot of data, which can be used for these legitimate purposes, the executed measures will need to be in compliance with the subject's right to privacy and data protection. The Centre for Computers and Law analyses the legal framework and supports the development of a concept that is in compliance with the right to privacy and data protection.

Horizon2020 – MARCONI

MARCONI aims to deliver a personalized radio experience ("hybrid radio") to the listener, paired with multiple opportunities for radio makers to engage with their audience. With Members from the Netherlands, Belgium, Switzerland, Great Britain as well as Austria, the University of Vienna is tasked with capturing the regulatory requirements that are relevant for interactive radio with engagement, interaction and personalisation, in particular the new General Data Protection Regulation and Digital Internal Market rules.

KIRAS – AREAS

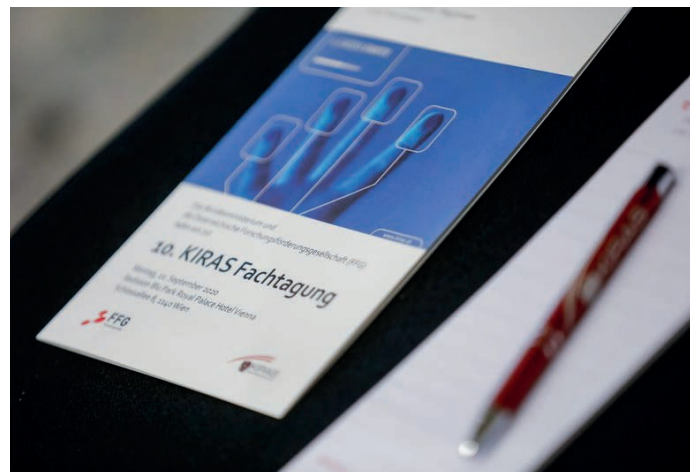
Concerning disaster management project AREAS aims to develop new strategies using aviation technologies in order to relay real time information to responsible authorities on national and regional levels. The Centre for Computers and Law provides expertise on the fields of aviation law and data protection to tackle issues on the legal and technical side. AREAS further strives to enhance interoperability between military and civil task forces as emergency responders.

KIRAS – EVE

The EVE project investigates how priority can be automatically given to emergency vehicles such as ambulances in cooperative, intelligent transport systems. For this purpose, the emergency vehicle communicates with traffic signal systems or other vehicles. Service Specific Permissions will be specified for communication in the networked, cooperative transport infrastructure (C-ITS), which is based on a separate public key infrastructure. The lifecycle management of these Service Specific Permissions plays an important role. The working group Legal Informatics deals with the framework conditions for Public Key Infrastructure (PKI) and interventions in traffic control systems as well as questions of data security and data protection.

EU – LAST-JD project

This program LAST-JD-RloEist - Law, Science and Technology Joint Doctorate: Rights of the Internet of Everything is funded by the EU under the program H2020-MSCA-ITN-2018 - Marie Skłodowska-Curie Innovative Training Networks - Joint European Doctorates and lasts 4 years. Fifteen doctoral students have been jointly selected and will complete a doctorate at three universities - Bologna, Turin (among others) and the supervising university. They will receive a scholarship for this. The University of Vienna has awarded two places. The dissertation topics are "Distributed ledger technologies" and "Privacy and Data Protection Aspects in Internet of Healthcare". Furthermore, wide ranges of courses are offered at the respective universities.



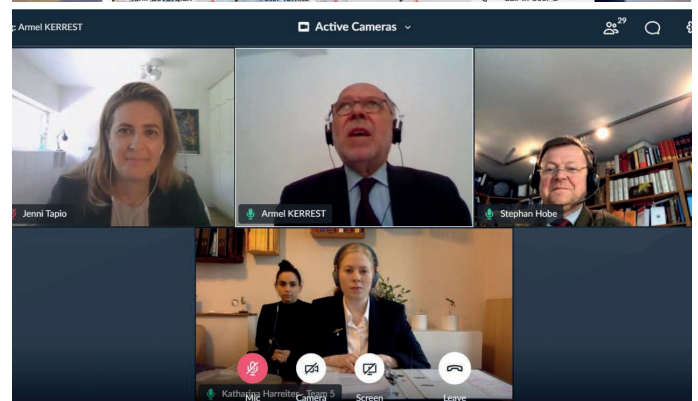
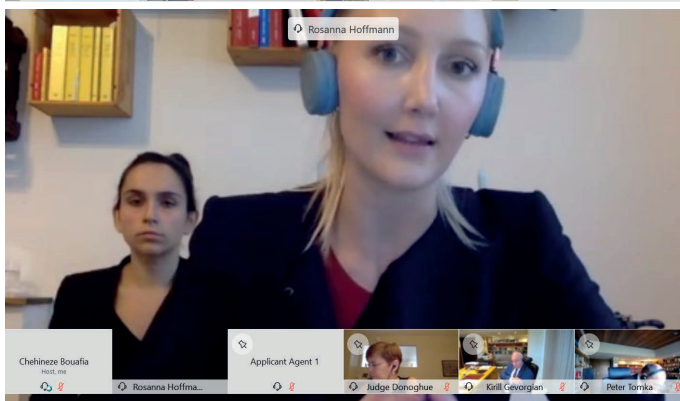
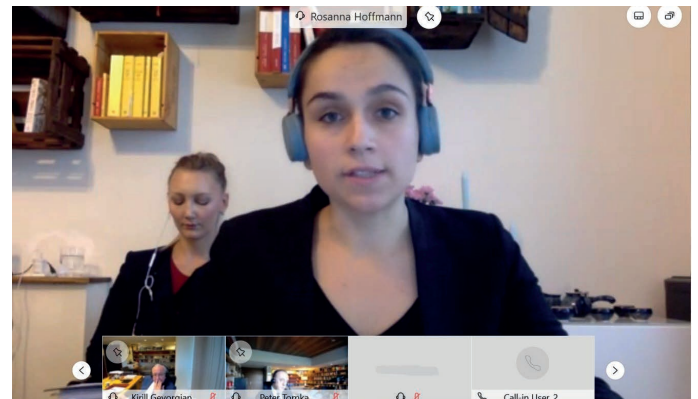
International Student Competitions

Manfred Lachs Space Law Moot Court

In the academic year 2019/2020, a team from the University of Vienna participated in the Manfred Lachs Space Law Moot Court for the seventh time. Three students – Katharina Harreiter, Rosanna Hoffmann and Hristina Talkova – had been selected from several applicants in October 2019, to represent the University of Vienna. This year's case dealt with jurisdiction and control in space, space situational awareness and space debris.

The European Rounds should have taken place from 31 March - 3 April in Vienna, organised by the team of NPOC Space Law Austria under the direction of by Prof. Marboe. However, due to the COVID 19 pandemic the competition had to be held online. The four teams with the highest scores on their written memorials in Europe were invited to compete against each other in June. Rewarding their hard work the Viennese team was among these and was able to prevail against the University of Athens in the semifinals. Like the previous team of 2019 our students therefore advanced to the European Finals. They again delivered a convincing performance so that they could prevail over the team of the University of Leiden and win the first place in the European Rounds. Moreover, Hristina Talkova received the Best Oralist Award for her outstanding pleading performance.

The World Finals were also held online on 23 October. The team of the University of Vienna won the semifinal against the University of Pretoria (South Africa) and moved on to the final where it competed against the team of the National Law University Delhi (India). After the online pleadings by both teams the jury consisting of sitting judges of the International Court of Justice, Peter Tomka (Slovakia, President), Joan Donoghue (USA) and Kirill Gevorgian (Russia) declared the team of the National Law University Delhi (India) as the winner. The University of Vienna received the World Best Memorial Award, and Hristina Talkova was again crowned as Best Oralist.



During the written and oral preparation phases the three students were coached by university assistants Clara Baumgartner and Michael Friedl.

In 2021 the European Rounds shall again be organised by the NPOC Space Law Austria under the direction of Prof. Marboe, together with the European Centre for Space Law (ECSL), hopefully as a real event at the Juridicum in Vienna.

Philip C. Jessup International Law Moot Court Competition

Austria was again represented in the Philip C. Jessup International Law Moot Court Competition by a team of the University of Vienna. From October to mid-January, the Viennese team, consisting of Martin Baumgartner, Maria Förster, Nina Öllinger and Leonard Soldo, drafted their memorials and started to prepare their pleadings in February. From 5 to 7 March 2020 the Vienna team participated in the Jessup European Friendly Rounds, which took place in Prague, Czech Republic. In four competitive rounds against teams from Jordan, Kosovo, New Zealand and Panama the Viennese teams put their skills to the test and only barely missed the semi-final. Moreover, one of the four students was within the best 10 oralists.

The international rounds in Washington, DC were scheduled to take place from 12 to 18 April 2020, but had to be cancelled due to the COVID-19 pandemic.

The Philip C Jessup International Law Moot Court Competition is the world's largest and most prestigious moot court competition and is organized by the International Law Students Association (ILSA). Each year more than 100 teams from all over the world participate at the international rounds in Washington, DC. The Section for International Law and International Relations of the University of Vienna has participated at International Moot Court Competitions for more than 20 years and has regularly achieved outstanding results. The team was coached by Mag.a Tensin A. Studer and Mag. Johannes Tropper.

The team was supported by the law firms Schönherr, Dorda and Zeiler.



International Investment Arbitration Moot Court

The University of Vienna team reached third place at the Frankfurt Investment Arbitration Pre-Moot in Moscow. On 8 February 2020, a Pre-Moot took place at the Russian Arbitration Center in Moscow to prepare for the Frankfurt Investment Arbitration Moot Court in early March. The team supervised by Mag. Matthias Edtmayer und Mag. Julia Hildebrandt successfully prevailed against the strong international competition and reached the semi-finals. The competition in Frankfurt was cancelled due to COVID-19. We congratulate the team consisting of Sophie Aulitzky, Leon Gombos, Alexandru Repan and Sophie Tesarik on their outstanding performance in Moscow!

In 2020, the University of Vienna participated for the third time in the competition. The moot court combines contemporary international investment law with historical incidents. The students develop legal arguments for the solution of an international investment dispute and present them in a simulated arbitration. For this purpose, they represent the investor and the respondent state of the case and draft written skeleton arguments for each side. They then defend their submissions in oral hearings against teams from all over the world before renowned personalities of the investment arbitration community.



Coordination of Exchange Programs

Prof. Irmgard Marboe and Prof. Erich Schweighofer coordinate more than 210 places of the ERASMUS student exchange program. This represents the largest portion of available Erasmus places at the Law Faculty. The Section for International Law, therefore, coordinates the annual ERASMUS selection procedure for the entire Faculty. The Section has created a website for the ERASMUS program (<http://erasmlaw.univie.ac.at>) which is updated regularly in order to inform students in a comprehensive and timely manner. The support of the ERASMUS program includes information of prospective outgoing students at public events and in personal consultations, the development of a "Learning Agreement" including subsequent changes and adaptations, as well as guidance and supervision of the recognition procedure upon return, which includes writing certificates of recognition for diploma seminars. The Erasmus coordinators also serve as contact persons for incoming students from abroad, in particular with regard to advice and support with their "Learning Agreement". The ERASMUS stay abroad often triggers or increases the interest of students in international aspects of the law and legal practice. Many ERASMUS outgoing students are successful in Moot Courts abroad or after their return and chose elective subjects or fields of specialization of international relevance (European Law, Law of International Relations, Human Rights, Private International Law and Comparative Law, etc.). Every year in December or January an Erasmus-information event is organized together with the students union of the Law Faculty. At this event, the Erasmus Program is introduced and students are informed about the various steps of the application process. The event this year again attracted more than 300 students. However, in comparison to the overall number of students at the Vienna Faculty of Law, there is still room for improvement. Many students are concerned that their studies might be prolonged. The financial burden is also considerable, as Erasmus grants do not fully cover the additional costs of studying abroad. In February/March 2020, the section organized the Erasmus selection procedure of the Faculty of Law for the academic year 2019/20, in which over 200 candidates applied. The Coronavirus-Pandemic primarily had an impact on students spending their Erasmus semester in the summer semester of 2020, as most universities adapted to the new situation with distance learning, and most students came back to Austria to complete their exchange semester online. The students that were nominated for the winter semester 2020/21 have been given the possibility to postpone their stay to the summer semester 2021, which is why only ten people in total withdrew from their nomination.

The ERASMUS program of Prof. Marboe consists of contracts with 54 universities offering total of 167 places to ERASMUS students. In the academic year 2019/2020, 117 students were nominated to study abroad for one semester or a whole year. In addition, around 110 incoming students from ERASMUS partner universities as well as from other programs, such as the Non-EU Exchange Program, were welcomed at the Vienna Faculty of Law. In the following, the number of places available at ERASMUS partner universities for outgoing students in the program of Prof. Marboe as well as the number of nominated students are presented:
