Irmgard Marboe studied law and Roman languages at the University of Vienna (Austria) and at the Universidad Complutense de Madrid (Spain). Her doctoral thesis (1994) dealt with legal aspects of cultural subsidies under European law (State aid, prohibition of discrimination, taxation). Her post-doctoral thesis (“habilitation”) entitled “Die Berechnung von Entschädigung und Schadenersatz in der internationalen Rechtsprechung” was published in 2009. An abridged version in English with the focus on investment law (“Calculation of Compensation and Damages in International Investment Law”, Oxford University Press 2009, 2nd ed. 2017) has become a widely quoted standard work in international investment arbitration. More recently, she has contributed to the article-by-article commentary “CETA Investment Law” (Nomos/Hart 2022) and to “Schreuer’s Commentary on the ICSID Convention (3rd ed., Cambridge University Press 2022). As an expert in international investment law she is a frequent speaker at international conferences.

Another research focus is the international law of outer space. Since 2008, Irmgard Marboe is the head of the Austrian National Point of Contact for Space Law (NPOC) of the European Centre for Space Law (ECSL) (<https://npocspacelaw.univie.ac.at>). Between 2008 und 2012 she was the chair of the Working Group on “National Space Legislation” of the Legal Subcommittee of the UN Committee on the Peaceful Uses of Outer Space (UNCOPUOS), whose work resulted in the adoption of UN General Assembly Resolution No 68/74 of 11 Dezember 2013 entitled “Recommendations on National Legislation Relevant to the Peaceful Exploration and Use of Outer Space”. Between 2009 and 2015, she gave advice to the Austrian Federal Ministry for Transport, Innovation and Technology to draft the Austrian Outer Space Act (BGBl I Nr. 132/2011) and the Austrian Outer Space Regulation (BGBl II Nr. 36/2015). She also gave advice to other governments in their development of national space laws. She is member of the Directorate of Studies of the International Institute of Space Law (IISL) and received the “Distinguished Services Award” of IISL in 2016. She serves as an expert to the European Commission in ethics screenings of space related projects

proposed for funding under the EU research promotion programmes. She published numerous books and articles on the law on outer space, recently on the topic of “Legal Aspects of Planetary Defence” (Brill/Nijhoff 2021).

Other publications deal with Islamic law and international law as well as with the relationship of religion, law and the state. Between 2008 and 2018 she was the director of the Vienna International Christian-Islamic Summer University (www.vicisu.com). Between 2013 and 2018, she was Co-Rapporteur of the Committee „Islam and International Law“ of the International Law Association (ILA). She co-authored the book “Rule of Law, Freedom of Expression and Islamic Law” (Hart 2017) and participated in the “Elgar Encyclopedia of Human Rights” with a commentary on the Arab Charter of Human Rights (Elgar 2022).

She is the Vice-Chair of the Aerospace Advisory Board of the Austrian Research Promotion Agency (FFG) and member of the Panel of Arbitrators for Space-related Disputes at the Permanent Court of Arbitration in The Hague. Her teaching activities include lectures, courses, exercises and seminars on international law in German and English at the University of Vienna and at other universities in Austria and abroad. In 2014/15 and 2016 she was a visiting scholar at Stanford University (USA), and a visiting professor, in 2016/17, at the University of Western Sydney (Australia).
